REMEMBER: IT IS IMPORTANT TO TELL YOUR EMPLOYER ABOUT YOUR INJURY

- 1) If you suffer a work-related injury, your employer or its insurance carrier must pay for reasonable surgical & medical services, medicines, supplies, orthopedic appliances and prostheses, including training in their use.
- 2) To ensure that your medical treatment will be paid by your employer or its insurance company, you must visit one of the below noted licensed physicians or practitioners of the healing arts. You must continue to visit one of these individuals, if you need treatment, for 90-days from the date of your first visit. Failure to comply with this requirement may relieve your employer of liability to pay for treatments obtained within this applicable period.

- 3) After this (90)-day period, if you still need treatment, you may go to another licensed physician or practitioner of the healing arts for treatment. You must notify your employer, in writing, within *FIVE* days of the first visit to such provider. If you do not, your employer may not be required to pay for these services.
- 4) Your bills will be paid for IF: Your health care provider files reports as required, on a form prescribed by the Bureau of Compensation, within (10) days of beginning treatment & at least once-a-month thereafter, as long as treatment continues. The employer shall not be liable to pay for any treatment until a report has been filed containing: history, diagnosis, treatment, prognosis & physical findings.
- 5) If you are faced with a medical emergency, you may seek initial emergency treatment from the hospital or health care provider of your choice. Subsequent treatments required within the first 90-days from the first treatment must be provided by one of the health care providers listed above. In an emergency, please go to the NEAREST HOSPITAL EMERGENCY DEPARTMENT. You must immediately present to The Center for Occupational Health Park Care Division on the next business day to be evaluated for return-to-work duty status.
